Dr Contreras and distinguished board,

After viewing the May 11th board meeting multiple times and doing a bit of research I must support Mrs. Welborns concerns, regarding the proposed policy changes to the policy code: DC budgeting and fiscal management. We, the tax payers of Guilford County, have elected a board of education representative to be "our voice." There is a reason for electing a board, if for no other reason, it allows checks and balances. According to what I have been able to find, it appears no other county has given their superintendent this amount of control. The way I understand the proposed changes "our voice" would be lost, therefore, I am completely opposed to such a change in the budgeting and fiscal management policy.

In addition to the above concern, I would like to see board meetings opened to the public. I understand the concerns and measures taken thus far, but the tide has turned regarding the virus and I believe the board room could be opened to at least 50% capacity, especially since our schools returned to 100%

My third area of concern is the security of our schools. I can not understand why \$600,000 was spent on a study regarding security and the proposed changes have not been done. I realize there are plans to renovated or rebuild schools, but the safety of the students can not be put on a back burner while you have studies on buildings, meet with county commissioners , review bids for the work, etc... No child's safety is worth waiting on a building project. I implore you to make security your first priority. I would really like to see work done this summer, so at the very least the basic security measures are complete. There should never be broken doors or doors propped open. Please stop sitting on this matter! Any idea one may entertain regarding the removal of SROs is more than careless when it is obvious that some schools need more than one SRO on campus. Each student is your responsibility the moment they step foot on a school bus or school campus.

Thank you for each effort you make regarding our students education.

Hello Guilford County Schools Administrators,
